

OFFICIAL RULES

Paperblanks® Christmas 2017 Advent Calendar (“Competition”)

Dublin 2, Ireland (The “Sponsor”)**

ELIGIBILITY

Void where prohibited by law. Eligible entrants (“Entrants”) must be legal residents of Germany, Austria, France, Belgium, UK, Ireland, Spain, Italy, the Netherlands, Scandinavia, Portugal, USA, Canada, Australia and New Zealand except where void.

The contest is void in Puerto Rico, U.S. territories and possessions, outside of the U.S., and where prohibited by law. Entrants must be at least eighteen (18) years of age at the time of entry or the age of majority in their country of residency, whichever is older. Employees, directors and officers and their immediate families (spouses and siblings, parents and children and their spouses) and household members of the Sponsor (defined below), and its parent companies, subsidiaries and affiliates, distributors, dealerships and companies involved in the implementation and execution of the Competition (collectively the "Competition Entities") are not eligible to participate. Winners may be required to sign an Affidavit of Eligibility and Liability/Publicity Release (the "Affidavit/Release") as a condition to the delivery of the applicable prize at the discretion of the Sponsor.

If the Sponsor decides to reconvene the Competition after a suspension, the determination of the prize winner

will be made, from among all eligible, non-suspect Entries received as of the date of the suspension, as the Sponsor determines in its sole discretion. Entries not complying with all rules are subject to disqualification.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and

enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of the Sponsor in connection with the Competition, shall be governed by, and construed in accordance with, the laws of the Republic of Ireland, without giving effect to any choice of law or conflict of law rules which would cause the application of the laws of any jurisdiction other than the Republic of Ireland.
